4. Provide government, industry and educational institutions with a mechanism for identifying hazardous materials management professionals.

The EHMM Course

The “Essentials of Hazardous Materials Management” Course (formerly called the CHMM Overview Course), along with the AHMP Hazardous Materials Management Desk Reference, 3rd Edition book will provide a comprehensive review of environmental laws, regulations and applicable health topics designed to assist individuals in preparing for the CHMM exam.
